Based on the Law on Local Self-Government (LLSG), No. 03/L-040, article 12 paragraph 12.2 d), Statute of Junik Municipality (dated 29.9.2010), article 22 paragraph 22.1 point 4, Municipal Assembly in Junik at its regular meeting held on 30.04.2018, took this:

DECISION

for the establishment of the Municipal Council for Community Safety

- I. By this decision is established the Municipal Council for Community Safety in the Municipality of Junik / in further text MCSC.
- II. MCSC is composed of: (article 4 Administrative Instruction, No. 27/2012 MIA 03/2012 MALG for the Municipal Community Safety Councils)
- 1. Mayor of the Municipality (Chairperson);
- 2. Commander of Police Station;
- 3. A representative of the Islamic Community;
- 4. Chairperson of the Communities Committee;
- 5. Official for Gender Equality;
- 6. Director of Education Directorate:
- 7. Chairman of the Council of Parents of Education of the respective Municipality;
- 8. A representative of the KSF;
- 9. A representative of each Local Public Security Council;
- 10. Chairperson of the Community Safety Action Team;
- 11. a representative from the Municipal Civil Emergency Sector;
- 12. a representative of the Municipal Office for Communities and Returns;
- 13. a NGO representative,
- 14. a Local Media Representative,
- 15. a representative from the Business Community and
- 16. a representative from the Community of People with Disabilities.
- III. The duties and responsibilities of MCSC are regulated in Article 6 of Administrative Instruction No. 27/2012 MIA 03/2012 MALG for the Municipal Community Safety Councils.
- IV. Chairperson of the MCSC is the Mayor of Junik Municipality (Article 8 of U / A, No.27 / 2017 of MIA and No. 03/2012 of MALG).

V. The Mayor of Junik Municipality is obliged to address in writing to the subjects specified in Section II of this Decision for sending their representatives.

VI. Based on the proposals of the respective communities, prepares the list of members of the MCSC including all stakeholders, as defined in Article 4 of this Administrative Instruction, and submits the same list to the Municipal Assembly for approval;

VII. MCSC, within 30 days of the constitution, compiles the annual work plan, and submits it to the Assembly for approval.

VIII. MCSC is obliged to inform the Municipal Assembly two (2) times within a year about MCSC activities.

IX. The MCSC members have the same mandate as members of the Municipal Assembly of Junik.

X. This decision enters into force 15 days after the enrollment in the Protocol's Office of the ministry responsible for local self-government, as well as publication in official languages of the official website of the Municipality of Junik.

Based on the Law on Self-Government of Kosova Municipalities, No.03/L-040, Article 17 paragraph (f), Law No. 04/L-111 on Amending and Supplementing the Law No. 03/L-087 on Public Enterprises, Regulation No.02/2013 on the Criteria for the Establishment of Local Publicly Owned Enterprises and the Participation of Municipalities in the Boards of Directors of Regional Water Enterprises, Municipal Assembly at its regular meeting held on 31.05 .2018, issue this:

DECISION

- I. For the establishment of the Municipal Public Enterprise for Management of Municipal Services as follows:
- 1. Drinking water,
- 2. Irrigation water,
- 3. Sewage,
- 4. Maintenance of municipal roads,
- 5. Maintenance of municipal cemetery,
- 6. Maintenance of municipal parks and squares.
- II. The headquarters facility, company name, mode of organization and operation shall be determined by a separate act (statute) on the establishment of the enterprise.
- III. Junik Municipality as the founder of this enterprise will provide the necessary assets for the operation of this enterprise.
- IV. The enterprise will operate on the basis of self-financing, while the Municipality will retain the ownership right over the assets.
- V. The Municipal Assembly each budget year approves the utility tariffs that it offers the annual budget plan and the annual report of the enterprise.
- VI. The municipality establishes a special commission for the preparation of the necessary documentation according to the law on registration of the enterprise with the competent body of the Ministry of Economic Development.

DECISION

for the procedure for drafting the Regulation on Management of Municipal Cemeteries

- I. With this decision is initiated the procedure for drafting the Regulation for Municipal Cemetery Management / hereinafter referred to as draft regulation.
- II. The purpose of issuing and approving this (draft) Regulation, according to this decision is the establishment of a legal basis for the management of the cemetery.
- III. The holder of the (draft) Regulation from point I of this decision is the Directorate for Administration.
- IV. The holder of the draft (draft) Regulation is obliged to draft (draft) the Regulation within 6 months from the day of entry into force of this decision.
- V. The Mayor of Junik is authorized that after the entry into force of this decision to appoint a working group for drafting the (draft) Regulation from point I of this Decision.
- VI. The (project) Regulation should be put in a public review. Submission of (draft) Regulation for public review and time for submitting reviews and comments will be announced on the website of the Municipality of Junik.
- VII. After drafting, the (draft) Regulation is being processed by the Municipal Assembly for review and approval.
- VIII. The financial means for drafting the (draft) Regulation are provided by the budget of the Municipality of Junik.
- IX. Upon the entry into force of this decision, all legal provisions by which this field has been regulated are abrogated.

X. The Mayor of the Municipality, respectively Directorate for Administration, is responsible for implementing this decision.

XI. This decision enters into force 15 days after the enrollment in the Protocol's Office of the ministry responsible for local self-government, as well as publication in official languages on the official website of the Municipality of Junik.
