DECISIONFor the establishment of the Communities Committee

- I. By this decision the Assembly establishes the Communities Committee as a permanent committee in the Municipality of Junik and determines its structure.
- II. Based on the Administrative Instruction (MALG) on the procedure of establishment, composition and competencies of permanent committees in the Municipality, Article 10, paragraph 2, the Chairperson of the Communities Committee shall be elected by a majority vote of the members of the Committee.
- III. The Community Committee will have the following composition:
- 1. Dardane Shala member, political entity AAK PDK,
- 2. Kreshnik Maloku member, political entity AAK PDK,
- 3. ______ member, political subject LDK,
- 4. Zenel Maloku member, independent candidate,
- 5. Drita Salihu Hoxha member, political entity LVV,
- IV. The Community Committee is responsible for reviewing the compliance of municipal authorities with the applicable law and reviewing all municipal policies, practices and activities to ensure that the rights and interests of communities are fully respected. The Committee also recommends to the Municipal Assembly the measures to be taken to ensure the implementation of provisions relating to the need of communities to advance, express, protect and develop their ethnic, cultural, religious and linguistic identities, and to ensure adequate protection of community rights within the Municipality.

Pursuant to Article 12 paragraph 12.2 point d) and Article 14 paragraph 14.1 of the Law on Local Self Government (Law No. 03/L-040, ONRK No. 28/2008); Article 10 paragraph 10.2 and paragraph 10.3 of the Law on Agricultural Land (Law No. 03/L-040, ONRK No. 13/2007) and Article 8 paragraph 8.4 of Administrative Instruction for Changing of Destination of Agriculture Land into Construction Land (A/I No. 41/2006) and Article 22 paragraph 22.1 point 4 of the Statute of the Municipality of Junik, the Municipal Assembly of Junik at the regular meeting held on 28.06.2018, issues:

PRELIMINARY DECISION For the permanent transformation of agricultural land into construction land

- I. By this decision is changed the destination of agricultural land into construction land.
- II. Cadastral parcel with the number P-73105038-04164-4 with total surface of 6000,0 m2 cadastral zone Junik, with culture of agricultural land of the 3rd grade, in the place called Arat e Erenikut Mali i Hereqit change the destination of the surface of 6000,0 m2 from current use as agricultural land into construction land.
- III. Cadastral parcel with the number P-73105038-04164-6 with total surface of 14000,0 m2 cadastral zone Junik, with culture of agricultural land of the 3rd grade, in the place called Arat e Erenikut Mali i Hereqit change the destination of the surface of 14000,0 m2 from current use as agricultural land onto construction land.
- IV. Cadastral parcels from point II and III of this Decision after issuing the final decision should be identified as a construction land in the Municipal Development Plan.
- V. Compensation for transformation of agricultural land into construction land according to point I of this Decision shall be paid in administrative procedure when applying for a construction permit according to the criteria set forth in Article 14, paragraph 14.2, item a) of the Administrative Instruction for the Change of Destination of Agricultural Land (A/I No. 41/2006).
- VI. Upon the entry into force of this Decision all legal provisions with which this field has been regulated are abrogated.
- VII. The Mayor of Junik, respectively Directorate of Urbanism, Cadaster and Environment of the Municipality of Junik is responsible for the implementation of this decision.

VIII. This Decision enters into force 15 days after being registered with the Protocol's Office of the ministry responsible for local self-government, and published in official languages on the official website of the Municipality of Junik.
