DECISION

for the formation of the Working Group for the drafting of the (project) Annual Work Plan of the Municipal Assembly of Junik for the year 2019.

- I. This Decision establishes a Working Group for the drafting of the (project) Annual Work Plan of the Municipal Assembly of Junik for 2019 year/ hereinafter referred to as the Working Group/.

- IV. The deadline for drafting of the (project) Work Plan of the Municipal Assembly of Junik is at the latest by the end of September this year.
- V. After drafting of the (project) Work Plan by the Working Group, the (project) Plan is submitted to the Municipal Assembly of Junik for review and approval.
- VI. Upon the entry into force of this Decision, other decisions with which this area has been regulated are abrogated.
- VII. This Decision enters into force 15 days after its registration in the Protocol's Office of the ministry responsible for local self-government, as well as publication in official languages in the official website of the Municipality of Junik.

DECISION

for the location of the Waste Landfill from Construction and Demolition of Construction Facilities in the territory of the Municipality of Junik.

- I. By this decision is assigned the location for the Waste Disposal from the Construction and Demolition of Construction Facilities in the territory of the Municipality of Junik in the cadastral parcel P-73105038-05120-0, with total area of 6727 m2, cadastral zone of Junik, with culture Uncategorized Street, in the place called "Arat e Gata-Luqe-Kloshe".
- II. The location mentioned in paragraph 1 of this decision is allocated according to the Local Waste Management Plan No. 9-180/539, dated 18.01.2018, and will be used for dumping solid waste until reaching the appropriate level by road infrastructure.
- III. The Directorate for Public Services, Protection and Rescue is obliged to daily conduct inspections at the above mentioned location for the purpose of waste supervision and at the same time in cooperation with the Directorate for Urbanism, Cadaster and Environment to follow up the level of the road in question.
- IV. Upon the entry into force of this Decision, other decisions with which this field has been regulated are abrogated.
- V. This Decision enters into force 15 days after the enrollment in the ministry's office responsible for local self-government, as well as publication in official languages on the official website of the Municipality of Junik.

DESICION for the approval of the Municipality of Junik Budget for 2019

- I. By this Decision is approved the Budget of the Municipality of Junik for 2019, proposed by the Mayor of Junik.
- II. The total budget of the Municipality of Junik for 2019 is: $1,784,765.00 \in$, and is distributed in the following budget lines:
- 1. The staff for the year 2019 is **163 workers.**
- 2. Wages and Salaries Category for 2019, is: 1,127,723.00 €
- 3. Goods and Services Category for 2019, is 172,899.00 €
- 4. The category of Expenditures for the year 2019 is 36,200.00 €
- 5. The category of Subsidies for 2019 is **30,500.00** €
- 6. Capital Expenditure Category for 2019 is 417,443.00 €

The total budget approved for the year 2019 is 1,784,765.00 €
